**NOTIFICATION**

S.O..... In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act.

a) In the said First Schedule against "Mahatma Gandhi University, Kottayam, Kerala" and under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Bachelor of Medicine and Bachelor of Surgery"

MBBS

(This shall be a recognised medical qualification when granted by Mahatma Gandhi University, Kottayam, Kerala in respect of students being trained at Sree Narayan Institute of Medical Sciences, Chalakka, Kerala with annual intake of 100 MBBS students on or after September, 2014.

- Note to all:
1. The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
  2. The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
  3. Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute/medical college.

**Sub:- Recognition/Approval of Sree Narayan Institute of Medical Sciences, Chalakka, Kerala for the award of MBBS degree (100 seats) granted by Mahatma Gandhi University, Kottayam u/s 11(2) of the IMC Act, 1956.**

Sir,

I am directed to inform you that an assessment to assess the undergraduate teaching and training facilities available at Sree Narayan Institute of Medical Sciences, Chalakka, Kerala alongwith the standard of examination for recognition/ approval of the college for the award of MBBS degree granted by Mahatma Gandhi University, Kottayam u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 16<sup>th</sup> & 17<sup>th</sup> September, 2014. The assessment report (16<sup>th</sup> & 17<sup>th</sup> September, 2014) was considered by the Executive Committee and subsequently by the General Body of this Council at its meeting held on 26<sup>th</sup> & 27<sup>th</sup> March, 2015. The Council approved the following recommendations of the Executive Committee:-

*"The Executive Committee of the Council considered the matter with regard to Recognition/approval of Sree Narayana Institute of Medical Sciences, Chalakka for the award of MBBS degree for 100 seats granted by Mahatma Gandhi University, Kottayam and decided to recommend to the Central Government for approval u/s 11(2) of the IMC Act, 1956 from 2014.*

*The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-*

*8 (3) ...*

*(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.*

*(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.*

*(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute....."*

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing Sree Narayana Institute of Medical Sciences, Chalakka for the award of MBBS degree when granted on or after Sept., 2014 by Mahatma Gandhi University, Kottayam.
