ANTIRAGGING AWARENESS PROGRAMME 2014 & INAGURATION OF LEAGAL AID CLINIC

Anti Ragging awareness programme was conducted at Sree Narayana Institute of Medical Sceiences, Chalakka under the auspices of Taluk Legal Services Committee, North Paravur on 20th October 2014, at the College Lecture Hall. The function was presided over by the Principal and welcomed the gathering.

The Chief Guest, Additional District Judge of North Paravur Sri P.S Antony inaugurated the programme. Honorable Judge, at the outset, described the evolution of ragging from English schools and later on how it became a menace to the society and student community. Quoting actual cases he described the seriousness of the acts and how it affects students community. He also enumerated the legal clauses and its implications to the students. Thus he gave an overall outline of antiragging laws and its implications.

President Bar Association, North Paravur, Adv. Easannan Namboothiripadu and Mr. E.A Subramanian spoke on the occasion. Prof. Dr. Raju Antony proposed a vote of thanks.

Two batches of medical students and faculty and other staff of SNIMS participated in the campaign.

The inaugural function was followed by a class for the students by Advocate Ayub Khan who went into all the legal aspects and consequences of ragging.
